ANNUAL GENERAL MEETING TO BE HELD ON 5 JUNE 2020

1. Background

The board of directors (the "**Board**" or "**Directors**") of Samko Timber Limited (the "**Company**") refers to:

- (a) its announcement on 8 April 2020 on the automatic extension of time to hold the annual general meeting ("AGM" or the "Meeting") of the Company for the financial year ended 31 December 2019 pursuant to Rule 707(1) of the Listing Manual of the Singapore Exchange Securities Trading Limited ("SGX-ST") provided by Singapore Exchange Regulation ("SGX RegCo"), in consultation with the Accounting and Corporate Regulatory Authority (ACRA) and the Monetary Authority of Singapore (MAS), in its news release issued on 7 April 2020, on the grant of automatic 60-day extension for all issuers with financial year-end between 31 December 2019 to 31 March 2020 to hold their AGMs;
- (b) the COVID-19 (Temporary Measures) Act 2020 passed by Parliament on 7 April 2020 which enables the Minister for Law by order to prescribe alternative arrangements for listed companies in Singapore to, *inter alia*, conduct general meetings, either wholly or partly, by electronic communication, video conferencing, tele-conferencing or other electronic means; and
- (c) the COVID-19 (Temporary Measures) (Alternative Arrangements for Meetings for Companies, Variable Capital Companies, Business Trusts, Unit Trusts and Debenture Holders) Order 2020 (the "Order") which was gazetted on 13 April 2020, and which sets out the alternative arrangements in respect of, *inter alia*, general meetings of companies.

2. Date, time and conduct of AGM

The Company is pleased to announce that pursuant to the Order, its AGM will be convened and held by way of electronic means on **Friday**, **5 June 2020 at 3.00 p.m.**.

3. Notice of AGM and proxy form

The Notice of AGM and proxy form will be sent to shareholders solely by electronic means via publication on the Company's corporate website at the URL <u>https://www.sampoernakayoe.co.id/investors/financial-news/</u> and will also be made available on the SGX's website at the URL <u>https://www.sgx.com/securities/company-announcements</u>. Printed copies of these documents will <u>not</u> be sent to shareholders.

4. No personal attendance at AGM

Due to the current COVID-19 restriction orders in Singapore, <u>shareholders will not be able to</u> <u>attend the AGM in person</u>.

5. Alternative arrangements for participation at the AGM

Shareholders may participate at the AGM by:

- (a) observing and/or listening to the AGM proceedings via live audio-visual webcast or live audio-only stream;
- (b) submitting questions in advance in relation to any resolution set out in the Notice of AGM; and
- (c) appointing the Chairman of the Meeting as proxy to attend, speak and vote on their behalf at the AGM.

6. Persons who hold shares through relevant intermediaries

Persons who hold shares of the Company through relevant intermediaries (as defined in section 181 of the Companies Act, Chapter 50), including CPF and SRS investors, and who wish to participate in the AGM by:

- (a) observing and/or listening to the AGM proceedings via live audio-visual webcast or live audio-only stream;
- (b) submitting questions in advance in relation to any resolution set out in the Notice of AGM; and/or
- (c) appointing the Chairman of the Meeting as proxy to attend, speak and vote on their behalf at the AGM,

should contact the relevant intermediaries (which would include, in the case of CPF and SRS investors, their respective CPF Agent Banks and SRS Operators) through which they hold such shares by **5.00 p.m. on 26 May 2020** in order for the necessary arrangements to be made for their participation in the AGM.
